# Allegheny County Courts Uses ID Shield to Protect Citizens from Identity Theft

#### **Background**

Allegheny County, with a population of approximately 1.3 million people, is the second largest county in the state of Pennsylvania. The Department of Court Records has three divisions: Civil/Family, Wills/Orphan's, and Criminal Court.

### **Challenge**

Allegheny County courts sought redaction software to protect sensitive information within public documents. The county's requirements included state-of-the-art software with the capabilities to minimize staff time spent on quality assurance, along with a high ease of use.

#### **Outcome**

In a competitive review of redaction vendors, the Department of Court Records selected Extract Systems' ID Shield. The county cited the responsiveness of the Extract Systems team during the evaluation and its flexibility in creating a workflow and financial structure for redacting day-forward documents side-by-side with back-filed documents. The county is processing approximately 4 million day-forward pages annually and is on schedule to complete about 10 million of its 30 million back-file pages each year for the next three years.

ID Shield automatically redacts Allegheny County court documents marked as "high confidence" where the software has clearly found sensitive data and there is no ambiguity. "Low confidence" documents, such as low quality historical documents, are reviewed by Allegheny County staff. This workflow is designed to reduce costs, increase efficiency, and eliminate human error.

Allegheny County deployed ID Shield to redact social security numbers, driver's license numbers, credit card numbers and numerous other account numbers from 30 million pages of historical documents from our three court divisions. We've successfully processed 4.3 million pages of our back-filed documents and we're using ID Shield to protect day-forward documents as well.

#### The Technology Behind ID Shield Redaction Software

ID Shield uses a state-of-the-art algorithm to find sensitive data types including: social security numbers, dates of birth, credit card numbers, CVV codes, account numbers, check numbers, expiration dates, names, postal and email addresses, and virtually all types of personal information within structured and unstructured documents. This core competency is a proprietary formula that incorporates pattern recognition logic, phrase context proximity, and keywords into the software based on the data that needs to be captured and secured. ID Shield redaction zones are burned in, making it impossible for identity thieves to retrieve private information. All hidden metadata associated with the original document is eliminated. The original document remains unaltered.
