# **Colorado Secretary of State Protects Personal Data in UCC Filings**

## **Business Challenge**

Colorado Secretary of State

When the Colorado Secretary of State disabled web access to secured transaction records, they had to go back to the "brick and mortar" way of doing business. The office still had large numbers of records requests, but processing them manually was not as efficient. With a small staff trying to carry out the work, a noticeable backlog quickly developed and customer service suffered.

### Solution

The agency sought an automated redaction solution to protect sensitive information electronically so it could fulfill records requests through a web-enabled self-service model. Project requirements included the ability to seamless-ly integrate with its in-house filing software. The Colorado Secretary of State selected ID Shield to process nearly 1.4 million pages of historical plus dayforward UCC filings to redact Social Security Numbers and Federal Employer Identification Numbers.

ID Shield processed the filings using a hybrid workflow. When ID Shield was highly confident there was no sensitive information or the sensitive information found could be accurately identified and removed, filings were automatically redacted without human intervention. When the software found sensitive information but reported low and medium confidence levels due to an irregularity, such as an 8-digit number as opposed to the 9-digit format of an SSN, ID Shield highlighted the low and medium confidence data and presented it for human verification.

ID Shield's document classification capability reviewed documents based on content and assigned a document type. Specific redaction rules were applied to each type. For example, Federal Tax Liens were not redacted.

ID Shield uses a state-of-the-art unstructured data analysis algorithm to find and redact all sensitive data types including: Social Security Numbers, dates of birth, Credit Card Numbers, CVV codes, account numbers, check numbers, expiration dates, names, postal and email addresses, and virtually all types of personal information within structured and unstructured documents. This core competency is a proprietary formula that incorporates pattern recognition logic, phrase context proximity, and more keywords into the software based on the data that needs to be captured and secured. ID Shield redaction zones are burned in, making it impossible for identity thieves to retrieve private information. All hidden metadata associated with the original document is eliminated. The original document remains unaltered.
